

Coast Capital Savings 2020 North Road Giveaway Contest Rules

THESE RULES GOVERN THE COAST CAPITAL SAVINGS 2020 NORTH ROAD GIVEAWAY CONTEST RULES. THEY EXEMPT COAST CAPITAL SAVINGS FEDERAL CREDIT UNION AND OTHER PERSONS FROM LIABILITY AND CONTAIN OTHER IMPORTANT PROVISIONS. BY ENTERING THE CONTEST, YOU ACKNOWLEDGE AND SIGNIFY THAT YOU HAVE READ, UNDERSTOOD, AND AGREED TO BE BOUND BY THESE RULES. IF YOU DO NOT AGREE WITH EACH PROVISION OF THESE RULES, YOU MAY NOT PARTICIPATE IN THE COAST CAPITAL SAVINGS 2020 NORTH ROAD GIVEAWAY CONTEST.

The Contest Period and Prizes

- The Coast Capital Savings 2020 North Road Giveaway Contest (the “**Contest**”) is run by Coast Capital Savings Federal Credit Union (“**Coast Capital**”).
- The Contest will run from 8:00 am PDT on Thursday, September 10, 2020 to 4:00 pm PDT on Monday, November 30, 2020 (the “**Contest Period**”).
- The potential winner will be selected on December 14, 2020, with a total of one (1) prize (the “**Prize**”) available to be won. The Prize will be awarded pursuant to the time frames in these Rules under the How to Win and Claim Your Prize section.
- **The Prize is \$10,000.00 (CDN) to be deposited into a Coast Capital product. In order to claim the Prize, the winner will be required to become a Coast Capital member that includes paying \$5.00 (CDN) towards a Membership Equity Share. For further clarity, in order to deposit the Prize into a Coast Capital product, the winner must first become a Coast Capital member as per Coast Capital’s Credit Union Rules, a copy of which may be found on Coast Capital’s public website.**

Eligibility

- This Contest is only open to legal residents of British Columbia who are, and have reached the age of 19 by the start of the Contest Period.
- Employees of Coast Capital and its affiliates and their immediate family members (defined as spouse, parent, child, sibling and their respective spouses) and household members are not eligible to enter the Contest.
- No purchase is necessary to enter the Contest.
- You are not required to be an existing Coast Capital member or become a Coast Capital member to enter the Contest.

How to Enter

- During the Contest Period, participants may earn one (1) entry into the Contest by making and attending an appointment with a Coast Capital representative at our North Road branch located at **3977 North Road, Burnaby, BC V3J 1S2** to submit an entry.
- Once a participant has either made and attended an appointment with a Coast Capital representative as outlined above, or contacted the Advice Centre to complete an entry as outlined above, the person shall be considered an entrant with one entry into the Contest.
- There is a limit of one (1) entry per person during the Contest Period.

- Every entry is subject to verification by Coast Capital. Any entry that appears to Coast Capital, in their sole discretion, to be incomplete, ineligible, improper or fraudulent may be disqualified, including but not limited to entries that are made contrary to these Rules, entries that are disruptive to the proper operation of the Contest, or entries that are in any way unjust to other entrants or potential entrants.
- All decisions made by Coast Capital, including but not limited to those concerning the eligibility or disqualification of entrants, are final and binding without right of appeal.

How to Win and Claim Your Prize

- One (1) potential winner will be selected through a random draw administered by Coast Capital at approximately 4:00 pm PDT on Monday, December 14, 2020.
- The odds of winning depend on the number of valid entries received.
- The potential winner will be announced at approximately 4:00 pm PDT on Monday, December 14, 2020. The potential winner be notified by telephone.
- If a potential winner does not respond to Coast Capital within 48 hours of being notified, Coast Capital reserves the right to disqualify the potential winner and select another potential winner through another random draw.
- The potential winner must claim the Prize within one (1) week after being notified of being a potential winner, or within an acceptable time limit at the sole discretion of Coast Capital.
- To claim the Prize, a potential winner must do the following:
 1. Communicate with Coast Capital regarding Prize;
 2. Go to the Coast Capital North Road branch or, at Coast Capital's sole discretion, an alternate location, following notification from Coast Capital that the Prize is available - having in mind public health guidelines and convenience of the potential winner;
 3. Provide valid proof of identity, age, and residence, and any other relevant documentation requested by Coast Capital;
 4. Complete a Declaration and Release Form, which includes correctly answering, without assistance, a time-limited mathematical skill testing question; and
 5. Become a Coast Capital member and open a Coast Capital product.
- In the event that a potential winner is disqualified or is otherwise determined to be ineligible, including if the winner does not become a Coast Capital member and open a Coast Capital product, Coast Capital may, in its sole discretion, hold another random draw to determine an alternate potential winner.
- The Prize must be accepted as described in these Rules and cannot be returned, transferred to another individual, or substituted for another prize. Coast Capital reserves the right, in its sole discretion and for any reason whatsoever, to substitute any prize or part thereof, with another prize of equivalent or greater value.

Release and Exclusion of Liability

- You agree to release and hold harmless Coast Capital and each of its agents, employees, directors, successors and assigns against any and all liability in any way associated with the Contest, including but not limited to claims for:
 1. Injury, loss, or damage of any kind resulting from the acceptance or use of a Prize or from participation in the Contest,
 2. Any harm that you may sustain or incur as a result of the negligence of Coast Capital,

3. Typographical or other errors in the offer or administration of the Contest, including but not limited to errors in advertising, these Rules, the selection and announcement of Prize winners or distribution of the Prize,
4. Lost, late, incorrect, incomplete, or misdirected Contest entries,
5. Failure of any reason whatsoever of a selected entrant to receive notice of a Prize,
6. Defects or delays in the Prize awarded that are outside of Coast Capital's control,
7. The use of your statements, place of residence and likeness, including as a result of distortion, blurring, processing or reproduction,
8. Any injury or damage to any person's computer or data contained therein or other property as a result of any person's participation in the Contest,
9. Any damage or loss, including any economic loss, special, indirect, or consequential loss or damage or punitive damages, whether in contract, tort, or under any other theory of law or equity, arising from, connected with, or relating to the Contest or the submission of entries to the Contest, or participation in the Contest, or the Prizes, regardless of the cause or any negligence by any of Coast Capital's employees, agents or representatives.

Personal Information

- By entering the Contest, you authorize Coast Capital to collect and use your personal information to administer the Contest.
- If you are a potential winner, you will be asked if you consent to authorize Coast Capital to broadcast, publish, and otherwise use your name, voice, likeness, statements regarding the Contest, and place of residence, for publicity purposes and to promote the Contest. If you consent, Coast Capital's use of this information will be done without any remuneration.
- All personal information collected for this Contest that is in the possession of Coast Capital will be destroyed in accordance with the Coast Capital Privacy Policy.

Dispute Resolution

- You agree that all disputes, claims and causes of action arising out of or connected with the Contest, prize or these Rules will be resolved individually, without resort to any form of class action, and exclusively by the appropriate court of the Province of British Columbia, Canada.

General Terms and Conditions

- Coast Capital reserves the right, in its sole discretion, to cancel, modify, suspend or terminate this Contest or to amend the Rules, without notice and without compensation to any participant in the Contest.
- Generally prizes and gifts are non-taxable, however you acknowledge and accept any responsibility of tax liability.
- The Contest and the Rules shall be governed by and construed in accordance with all applicable municipal and provincial laws in British Columbia and federal laws in Canada.
